

ECSI Skills Testing Center Scenarios

When a student takes an online, interactive course through ECSI, they can either purchase the access code for the course directly from ECSI or your Education Center may purchase the access code for them. Please review the process for each scenario below.

If the student purchases an access code directly from ECSI:

- 1 The student will complete the online portion of the course and receive a certificate for the online portion only.
